Admissions Policy for OVERSEAS CANDIDATES

Overseas candidates including NRIs who seek admission to IIM Shillong (IIMS) Post Graduate Programme (PGP) in Management can apply in the prescribed application form furnishing their latest GMAT scores. The scores should not be older than 24 months at the time of last date of application i.e. (28th February, 2019). IIMS considers the GMAT scores of the candidates living abroad in lieu of CAT -2018 score.

An Indian citizen living abroad (studying or employed) will qualify as an overseas candidate for the purpose of considering themselves for admission only if the period of stay is not less than 18 months (as on 28th February, 2019). Please note that there is no reservation for overseas candidates and the offer of admission will be made solely on the basis of merit as in the case of other applicants taking CAT-2018.

How to apply

The application form can be downloaded from the Institute's official website (www.iimshillong.ac.in). The application form needs to be filled in and must be e-mailed to admissions@iimshillong.ac.in as an attachment.

Thereafter, the applicant has to take a print of the filled in application form, put his/her signature on the proper place, and send it to the following address along with the necessary enclosures to

The completed application must be enclosed with the following documents as enclosures:

- Self-Attested Photocopy of the latest GMAT score card.
- Self-Attested Photocopy of the mark sheet of the Bachelor's Degree in any discipline or the aggregate percentage of marks obtained so far in the course of study for a degree by those applicants who are pursuing their final year of Degree course. A letter from the concerned institute stating "the conversion formula" (converting the grades to percentage) or "having no conversion formula" in case the institute follows a different grading system other than percentage.

- A Demand Draft / Banker's Cheque of US \$ 150 (non-refundable), drawn in favour of "Indian Institute of Management Shillong" and payable at Shillong as application processing fee. Please make sure that you fulfil the eligibility criteria for applying to IIM Shillong's Post Graduate Programme before sending the application form. Such candidates may also refer to the general shortlisting criteria which may also be applicable to them as available on IIM Shillong website.

Note: Last date for receiving the complete application form along with the above listed documents is 28th February, 2019.

Selection Process:

The Admissions Committee will scrutinize the applications and short-listed candidates, on the basis of their GMAT scores, scholastic performance, and work experience, if any, will be called for Writing & Verbal Skills Assessment Test (W&VSAT) in lieu of Group Discussion and Personal Interview (PI). The W&VSAT and PI will be held tentatively in four cities of India, namely, Bangalore, Delhi, Kolkata and Mumbai during January 2019- April 2019. Short-listed candidates will be required to attend WSAT & PI at any one of these centres at their own expense or through the video conferencing over Skype on date informed.

Final selection would be made from among those who attend the abovementioned process, based on their performance in all those parameters used for short-listing the candidates for the PI process, along with the performance in W&VSAT and PI. Selected candidates would be offered admission tentatively by mid of May, 2019. The candidates will have to register for the programme at IIM Shillong campus around third to fourth week of June, 2019.
