A. <u>INVITATION OF TENDER</u>

- Two (2) separate sealed envelopes should be used for submitting Tender Document and Earnest Money. Envelopes should be superscribed (a) "PRICE BID for SALE of USED VEHICLES" and (b) "Earnest Money for SALE OF USED VEHICLES" respectively.
- 2. The tenderers are expected to examine all the instructions, Proforma's terms & condition and specifications in the tender documents. Failing to furnish all information required by the tender document in any respect will be at the tenderer's risk and may result in the rejection of the tender.
- 3. The tender must be received not later than the date & time specified for submitting the same. In case, the date of submitting the tender will be declared as holiday by the Govt. of India then next working day will be treated as due date of tender.
- 4. Interested parties may send their sealed tenders in two separate sealed envelopes, one containing (i) "Tender Document" along with bidders' details and EMD details and another containing (ii) "Financial Bid" superscribing on the envelopes respectively. Both the envelopes should then be put in an outer cover indicating thereon:

5. The payment of Earnest Money should be done through online mode and a copy of the transaction should be enclosed with the envelope. A Committee of Officers constituted for the purpose before the tenderers or their authorised representatives who may wish to remain present. The tenders received after due date and/or time and without Earnest Money will not be entertained. In the first instance, envelopes containing Earnest Money and thereafter, Envelopes containing tenders will be opened.

B. <u>TERMS AND CONDITIONS OF TENDER</u>

The Tenderers are required to quote their highest rate of the vehicle mentioned in Annexure
 'A' annexed hereto. The auction shall be held separately for each used vehicles and not
 as a single lot. The bid will be confirmed in favour of the person quoting the highest rate
 in respect of each vehicle.

- 2. The tenderers are required to send their rate along with single payment of Earnest Money of Rs. 2,000/- (Rupees Two thousand only) though online mode for the both the vehicles. The Earnest Money will be refunded to the unsuccessful tenderer on their written request with respect thereto. Name of the firm/individual, telephone no. and address may be indicated on the reverse side of the Demand Draft.

- 4. The rates should be valid for a minimum period of 90 days from the date of opening of price bid.
- 5. Hypothetical or conditional Tender will be rejected. Tender once submitted shall not be allowed to be withdrawn or altered. If the tender is withdrawn or altered by the concerned party at any time after it is submitted, appropriate action may be taken.
- The IIM will deal with the tenderer directly and no middle-men/ agents/ commission agents etc., should be asked by the tenderer to represent their cause and they will not be entertained by IIM Shillong.
- 7. Over-writing/over-typing or erasing of the figures which render it doubtful or ambiguous arenot allowed and shall render the tender invalid.
- 8. The IIM reserves the right to make any change, at any time, to the terms and conditions of the Notice Inviting Tender and accept or reject any or all tenders wholly or partly without assigning any reason thereof.
- 9. The tenderer has to quote the rates at **Annexure** 'A' both in figures and word corresponding to the vehicle they are opting for.

10. Tender Document including the documents submitted therein must be duly signed/ stamped on all pages failing which the offer shall be liable for rejection.

- 11. Each tenderer has to certify that all the terms and conditions are acceptable to him. The Earnest Money shall stand forfeited in case of breach of any of the conditions mentioned in the tender document.
- 12. It is obligatory on each bidder that one person who desires to bid, should quote for the item as mentioned in the Annexure 'A' enclosed herewith. Used vehicles to the successful bidder shall be released only after depositing full and final payment in the IIM.
- 13. No bidder shall be permitted to bid for vehicles for an amount less than the reserve price of the particular vehicle as mentioned below against the vehicle. **The tenderer can bid for one vehicle or both vehicles.**

- 14. To be eligible for bidding, the bidder shall along with depositing the earnest money, submit written bid in closed cover in Proforma (Annexure 'A') for purchase of the used vehicle. The written bid shall not be less than the reserve price of the used vehicle, but may be more than that.
- 15. IIM Shillong reserves the right to accept or reject the tender without assigning any reason thereof.

C. <u>TERMS AND CONDITIONS FOR SUCCESSFUL TENDERER</u>

1. The successful bidder shall get the vehicle transferred in his name as per rules, at his own cost and responsibility, immediately on taking delivery and in any case within the time prescribed for this purpose. IIM Shillong shall not in any manner be concerned with or responsible for registration of the vehicle, and will have no liability whatsoever after the delivery of vehicle to the successful bidder.

- 2. The delivery of the auctioned vehicles will be arranged only after the successful bidder submits documentary evidence in support of residential status (PAN Card, Aadhar Card etc. in case of individual and Registration Certificate etc. in case of firms).
- 3. 50% percent of the bid amount is to be deposited by the highest bidder immediately on the spot whose bid will be provisionally accepted, by way of demand draft/pay order/ online mode, after adjusting the Earnest Money already deposited. If the amount is not deposited, the earnest money will be forfeited and the bidder will be barred from participating in future and the vehicle will be offered to the second highest bidder.
- 4. On final acceptance of the bid, the remaining 50% amount is to be deposited by the highest bidder within 3 working days failing which 50% amount already deposited shall stand forfeited and the said vehicle will be sold in auction. After full and final deposit the vehicle shall be allowed to be lifted by the bidder within 3 days.
- a. The successful tenderer will have to abide by the terms and conditions as may be fixed from time to time by the IIM Shillong.
- 5. IIM Shillong, in its discretion, reserves the right to reject or accept any bid, partly or completely, at any time without assigning any reason therefore. The decision of IIM Shillong in this matter shall be final.
- 6. The successful bidder shall take away the auctioned vehicle, at his own cost and responsibility, immediately on taking delivery and in any case within the time prescribed forthis purpose. IIM Shillong shall not in any manner be concerned with or responsible for these vehicle, and will have no liability whatsoever after the delivery of said items to the successful bidder.
- 7. Conditional bid will be rejected. If the bid is withdrawn by the concerned party at any time after it is provisionally accepted, the entire money deposited by him shall stand forfeited.
