LEAD STORY:

Covid-19 and Challenges for Socio Economic Policies in North East India

he tsunami of the recent Covid-19 has been one of the worst negative shocks which the global economy is facing today. Nations have been compelled to curtail most of their economic activities making the investment and investment multiplier work in the reverse way. The global economy is experiencing rapid downward slide in the growth rate and the worst is yet to come. Policy makers are no more talking of an impending recession, but a severe depression seems to be a certain outcome. India which has become an important player in the global market in recent years, has not only been a victim of the contagion effect, but negative factors have emerged from within the country itself, due to the rapid intensity of the Covid-19 in the country, that the expected annual growth rate seems to be a far cry. The adverse impact is experienced much more in those countries and regions of a country, which had just taken a few encouraging and positive steps in their developmental efforts in the recent times, after long spell of extreme poverty

and backwardness. The north eastern part of the country is one such region, which will now have to travel some extra miles and overcome many unwarranted challenges to once again pick up its growth momentum.

Most of the sectors with which the Dr APJ Abdul Kalam Centre for Policy Research and Analysis is working have been adversely impacted due to the pandemic. This has compelled the Centre to have a relook at policy orientation of all the six sectors. The policies have to be much more socially responsible, with greater focus in raising the livelihood of those whose source of income during the current pandemic has totally dried up. The economic activities in most of the states of the region, which were taking the first few steps towards growth and development have received a rude shock. With the shrinking of economic activities, a significant percentage of the labour force have lost their jobs, with very little chance of creation of fresh jobs in the labour market in the near future. This in turn has resulted in a drastic decline in the generation of income and consequent fall in demand for certain category of goods and commodities. On the other hand the production and supply of essential goods and food items have also gone down, due to the spread of Covid-19. As a result, a steady and rapid stride in price rise has been recorded in the entire country and more so in the north eastern region of the country. Miseries of the poor has thereby increased manifold. Some sectors such as tourism and hospitality does not seem to have any immediate prospect of recovery. Though with some meticulously planned effort and support from the government, some extent of revival may be possible in handloom and the handicraft sector, huge amount of public investment in the logistic and BPO sector does not seem to be an immediate

priority of government expenditure.

A" new policy orientation "especially for north east India is the need of the hour, so that before the situation worsens even further, the new policies can revive the economy of the states of the region, by confronting the current challenging situation in an innovative way. Local entrepreneurship has to be further incentivised, local demand has to be further capitalised for boosting up local production. Since there is a fear of the pandemic being spread from one place to another, no place including the north eastern region will encourage people, goods and other commodities from outside the region or even interstate movement of goods and services. This sentiment can be capitalised for developing indigenous products and consumption goods in the best possible manner. Government has no doubt provided some short term relief to some economic sectors and migrant workers who have lost their jobs. However, our policies will be expected to provide long term relief to the region and the workforce of the region who will be the main drivers of growth for the region in the coming years.

CAPACITY BUILDING WORKSHOP

During the period the Centre has organized two capacity building training for the entrepreneurs of North Eastern India. The first workshop was organized at Tourist Lodge, Dimapur, Nagaland for the entrepreneurs of Nagaland on 21st January 2020 in collaboration with

Toka Multipurpose Cooperative Society, Dimapur. It was attended by 35 entrepreneurs from Nagaland.

The workshop was coordinated by Centre Manager Dr Bhaskar Kumar Kakati and Shri Sridhar Lakshman, the Managing Trustee of BASECAMP Social Research Foundation and the Secretary of Toka Multipurpose Cooperative Society, Mr K. Kathi Chishi took a session on marketing and financial management.


