consultation between the Ministry of Development of North Eastern Region (DONER) and the Chief Ministers of States of the region.

ELIGIBILITY CRITERIA

Candidates should have

- A Master's Degree (bachelor's degree obtained in 10+2+3 pattern, followed by a master's degree) or a 5-year Integrated Master's Degree (obtained after completing higher secondary schooling in 10+2 pattern) in any discipline, with at least 55% marks in the bachelor's and 60% in the master's degrees
or
- A Master's Degree (A 4 year / 8 semesters Bachelor's degree (10+2+4 pattern) with at least 6.5 CGPA or equivalent marks, followed by a master's degree
or
- A professional qualification like CA, ICWA, CS with at least 55% marks in B.Com degree.

THE PROGRAM ENDEAVOURS TO PROVIDE YOU WITH

- 01 Inputs for domain knowledge
- 02 Understand knowledge creation process
- 03 Critically examine existing body of knowledge
- 04 Formulate research questions to aid knowledge generation facilitation by gaps in existing body of knowledge
- 05 To devise/design a strategy to extract the potential solution and possible generalization extension
- 06 To implement the strategy towards attaining solution for the identified research question
- 07 To document the problem, process and solution
- 08 To solicit feedback through scholarly publication and get recognized

In case of grades / CGPA, the conversion to percentage of marks would be based on the procedure certified by the respective University/ Institution. If a University/ institution confirms that there is no scheme for converting CGPA into equivalent marks, the equivalence would be established by dividing the candidate's CGPA by the maximum possible CGPA, and multiplying the result by 100.

The above qualification should be from any of the Universities incorporated by an act of the central or state legislature in India or other educational institutions established by an act of Parliament or declared to be deemed as a University under section 3 of UGC Act, 1956; or, recognized by the Ministry of HRD, Government of India.

TEST SCORES AND VALIDITY

- IIM Shillong will consider valid scores of GMAT, GRE, CAT (For last 2 years), GATE or JRF(NET) for admission to PhD (WP) program. Valid score need to be entered while filling the application form.
- The following categories of candidates are to be exempted from standard tests stated above but will be required to produce two reference letter from senior leadership

A. Graduates of PGP programs (2 years fulltime) of IIMs or an Indian University that has features in the top 50 institute/universities as per the NIRF list released by the Government of India. (List of Management Schools, any year) with CGPA 6.5 out of 10 or equivalent.

B. Individuals with at least 10 years of rich management experience from government or non- government sector.

C. Individuals with minimum 5 years of post PGP experience with PGP from IIMS

SELECTION PROCEDURE

Candidates eligible as mentioned, will be shortlisted based on recommendation of the appropriate committee. The shortlisted candidates will be invited for personal interviews (and/or written test) online for final selection.

RESERVATION POLICY

Reservation for eligible categories will be as per Government of India rules applicable for doctoral program at the time of admission.

APPLICATION PROCEDURE

The application form should be filled up and submitted Online.

The candidates are requested to be careful while filling in the form and to check the same before submitting it. In case any candidate submits the form more than once. The first submission will be considered.

The candidates should take the print out of the online form before submitting the same. If the candidate is applying for two areas, two copies must be submitted.

The soft copy of the application form, one for each area with a recent photograph pasted with all the supporting documents (including self attested copies of mark sheet and certificates of all public examinations starting from 10th, experience certificate, relevant score card, age proof etc.) attached separately with each form may be sent online.

PROGRAM DURATION

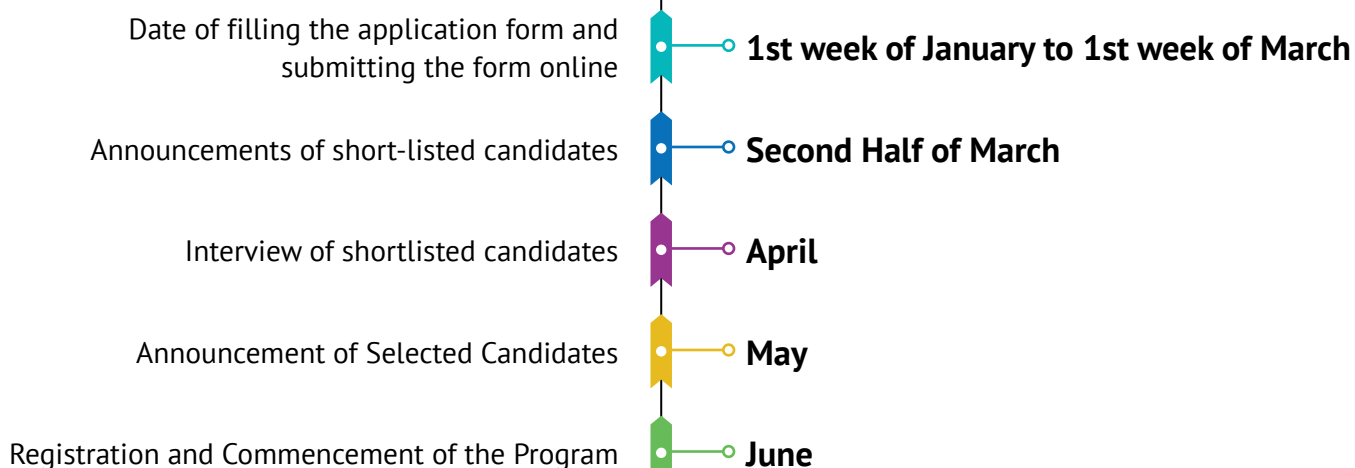
The minimum commitment to the program is 3 years, but scholars are expected to complete the program in four years and ensure that they complete the requirements of the program within this stipulated time. In case scholar is not able to complete the program in four year, they can be given two extensions of 6 months each depending upon their progress.

PROGRAM CONTINUATION

The candidates who go beyond the above stipulated time may be allowed to continue in the program depending upon their progress and with payment of continuation fee but not beyond 7 years as under:

- After completion of 4 years into the program an extension of one year will be given subject to a payment of continuation fee of Rs.25, 000/- every 6 months.
- After completion of 5 years into the program an appeal to the Director has to be made and such participant may be allowed to continue in the program on a six monthly extension basis for a period of maximum of two years subject to payment of a continuation fee of Rs. 50,000/- every 6 months.
- Beyond 7 years there will be no further extension.
