- 3. It will be the prerogative of the Institute to place the supply order for the whole lot/item or in piecemeal basis depending upon the requirement of the Institute. The Institute shall have the right to reject any tender without assigning any reason thereof. No correspondence will be entertained in this regard. Only one best quality item (according to our specification) should be quoted against the item.
- 4. Items will be required to be supplied in a staggered manner as per requirement of the Institute
- 5. Bidders will require to provide samples of the above items when asked for by the Institute.
- 6. The Institute reserves the right to increase or decrease the quantity to be ordered up to 25% of the bid quantity at the time of placing the order. The Institute also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
- 7. Validity of quoted rates is for a period of 365 days.
- 8. Stores will be accepted subject to the verification and inspection by the competent authority.
- 9. Time schedule of delivery is within <u>30 days</u> of receipt of supply order or else deduction on gross bill @0.5% per week or part thereof will be made as liquidated damages/ delay in supply subject to maximum of 10% of the value of the delayed supplies.
