## Background and objectives: -

The Gati Shakti Chair Professor will undertake activities aimed at research and publication, policy advice, and capacity building in the North-Eastern Region (NER) of the country, for the promotion and development of multimodal connectivity, integrated logistics, resilient supply chain, sustainable infrastructure, and allied areas thereby promoting economic growth and fostering sustainable development in the region in particular and the country in general. The Gati Shakti Chair Professor will undertake the designated activities assisted by domain experts from within the organization and draw upon the experience, knowledge, and insights of external stakeholders.

The Gati Shakti Chair Professor is expected to undertake, among other things, high quality academic research on multimodal logistics and work with post doctorate fellows and research associates as well as supervise the research of PhD scholars, facilitate internationalization of research, lead executive education to enhance capabilities in the regions, work towards strengthening links with key stakeholders, help in developing strategies and policies for multimodal connectivity, integrated logistics, etc., and mobilize additional financial sources. Further, the Chair Professor is expected to liaise with government officials, both from the Central and the State government of the region, and with various bodies and organizations, from both public and private sectors, to understand the challenges and come up, among other things, with actionable and viable recommendations towards policy making, developing infrastructure masterplan, human resource needs and implementation of roadmaps.

## **ELIGIBILITY**

Professor: Regular / Retired faculty members of the Institutes/Universities of repute holding the position of

Professor are eligible to apply. The candidates should possess a PhD in supply chain management or logistics and distribution management from a reputed institution/university. Candidates should preferably possess prior experience as principal investigator (PI)/co-PI in various research /consulting projects in the domain of supply chain management. The candidate should have also

demonstrated research in related fields through quality academic publications.

Or

Professor of Practice: Person with at least 15 years of experience in supply chain management or logistics and

distribution management in organization/institution of repute in Government / Private Sector and have significant demonstrable and documented contribution in the area of supply chain and logistics. Such candidate should have published in academic journals and/or have produced

industry white papers, policy documents, etc.

**Age limit:** Should not exceed **60 years of age** (as on 30 September 2025)

Number of Post: 1 (one)

**Period of Appointment:** The position is on contract for a maximum tenure of **5** (five) years only.

Emoluments: Rs. 2,50,000/- per month fixed

Other allowances: Rs. 30,000/- per month House Rent Allowance

Rs. 5,000/- per month Medical Allowance Rs. 7,500/- per month Transport Allowance

Rs. 1,500/- per month Telephone & Internet Allowance

**Incentives:** The following incentives will be given based on Performance
